The Program Change Request for MSW/MBA, MSW/MHA Joint Degree Program was tabled by the committee due to several required changes and questions for the department including but not limited to, adding the criteria and deadline date for admission into the program, adding the catalog changes, listing the 30 unique required credits for the MBA, listing the credits required for the MSW, adding the letters of support from the College of Business, articulating that students should apply to both programs, and indicating that students are only guaranteed admission if they have met the requirements for both programs.

The Program Change Request for College of Nursing University Graduate College Governance Policy was tabled by the committee due to several required changes and questions for the department including but not limited to providing a color version of the redline catalog changes, indicating what occurs when a faculty has left employment at the University and no longer wishes to assist the student, spelling out “DNP” making sure everything aligns with the governance document, and indicating how students register if the faculty is no longer employed at the University.

- iii. The Program Change Request for (Geographic Information Systems Certificate was approved unanimously by the committee.
