A. All consent agenda items were approved by the Council without objection and will now move to the Steering Committee and on to the University Faculty Senate. The action agenda was held up pending a review by the College of Engineering and their approval with memo.

V. Graduate Tuition Benefits Proposed Policy Change

The proposed new Graduate Tuition Benefits Policy was discussed. Dr. Rosson stated that the policy change has moved further down the road. Final items to be defined by the working group are the definition of RAs, GTAs and GAs.

An agreement on the budget is close. Non-Academic GAs will not be paid by the tuition waiver budget. At this time 44 GAs fit into this category. Some RAs in residence halls will not be paid out of the waiver budget, per Dr. Rosson. The major effort of the Graduate College was to create Banner codes and index numbers in order to post these classifications. The vision of research benefits is that the out of state portion of tuition would be paid by the Graduate College and the in state portion paid by the individual colleges. A website of FAQ will be set up. Dr. Rosson will meet with Dept. Chairs and Program Directors of all colleges. Graduate students are welcome.

Dr. Floyd expressed concern about benefits for non-academic GA's. Dr. Rosson agreed that a town hall meeting and a roll out with information will be forthcoming.

VI. SPOTS – Electronic for On-Line and Live classes-discussion

Dr. McDaniel referred the issue of online SPOT assessments to the Senate Assessment Committee. The Committee will be making a recommendation to the Senate soon. Dr. Floyd asked if the UGC should make recommendations. Several members offered suggestions and discussed concerns. Dr. Zilouchian suggested a student survey to determine which method is the best for student evaluations. Dr. Poulson said more information is needed on making this a 100% completion method by students. She asked about the parameters. Dr. Peluso suggested researching this with other schools that have tried online assessments. Dr. Floyd agreed to express UGC opinions and concerns to the Committee and to Steering when this matter is presented.

VII. Updates: Catalog Revision Process and Electronic Plans of Study

The meeting went well. The process is working. Changes are made in Fall and Spring.

Janelle Petak and Susan Fulks presented updates on the Electronic Plan of Study and Reference Letters. Four colleges are trained on the POS. It was suggested that training for Arts and Letters take place during the meeting scheduled with Dr. Rosson. Susan Fulks presented some of the screens used for the online Reference Letters. OIT is working on it. There will be the same roll out for training as used for the POS.

VIII. Other

Dr. Rosson spoke about Graduate Faculty Appointments. There was an external member elected to Grad Faculty in Biology with expertise in Psychology, with an overlap of 2 years. The new app could extend the time of the appointment. The College of Education has an A,B,C levels within the Graduate Faculty levels. Dr. Floyd pointed out that College Graduate Governance documents outlining processes for approval were all approved within a year of adopting the University Graduate Governance Document and that, to the best of her knowledge, the COE has been following the governance documents as approved. If there are issues with appointments the matter should be placed on a regular meeting agenda.
